# The Book of Ezra

AN INDUCTIVE BIBLE STUDY

### CHAPTERS ONE & TWO

1. Read Jeremiah 52, and 2 Chronicles 36:1-21 and gift a brief history of why and how the Israelites are living in Babylon.

• What change sets the scene in the opening verses of Ezra (v1; cf. 2 Chron. 36:22-23; Dan. 2:39).

• How do Jeremiah 25:1-13 and 29:10 help us understand the events recorded in Ezra 1:1 (cf. Dan.9:2)?

• How does the information provided by the prophet Isaiah in Isa. 41:2; 44: 26-28; 45:1, 4-5, 12, 13 contribute to the record of Cyrus' edict (vv. 2-3)?

• What other elements are included in Cyrus' edict to fulfill Isaiah's prophecy (vv.3-4)?

• Which Israelite tribes participated in the return to Jerusalem, and why was this (v.5; I Kings 12; Dan. 1:1)?

• Contrast the Israelites who returned to Jerusalem with those who did not (vv.5-6).

• How did God use each group to accomplish His will (vv. 5-6; cf. Ex. 12:35-36; Ex. 25:1-9)?

• In addition to the edict itself, how does Cyrus enable the Israelites in their return to Jerusalem (vv. 7-11)?

5. Read Exodus 25-31:11, which outlines God's instructions for building the Tabernacle, its contents, and the priestly garments used for worship, and explain how God expected His people to approach Him in worship.
